Change in station limit from (S05564LZ) Chainage 0 - Chainage 170 to (S05564LZ) Chainage 0 - Chainage 393 since the whole stretch of road section (S05564LZ) Chainage 0 - Chainage 393 with a total length of 393.00 meters has no existing drainage structure.

 Decreased in physical target from 1,506.00 lineal meters to 1,125.00 lineal meters due to the required size of RCCP from 30" diameter to 36" diameter and provision of Reinforced Concrete Manhole.
