**Reason/s for Modification**

In conformity to the procedure in the request for modification of project title, listed below are the facts for consideration that should justify the approval of the same.

1. There are revisions in the location, as can be verified in the approved plans. It was transferred on the opposite side which is at Barangay Poblacion. Due to scouring of soil on the said location, construction of Retaining Wall is considered because of its durability instead of Grouted Riprap. Due to these changes, there will be an increase of unit cost per lineal meter at the approved Plans and Program of Work.
2. There are revision in the station limits due to the existing Grouted Riprap as per original plan based on original location at Brgy. Putatan;
3. Based on the original location, it was requested and intended for construction of grouted riprap having a target of 124 lm, however as per approved plan it was designed as Retaining Wall with a height of 5.0m and a target of 93.5lm

Finding the herein request for modification in order, it is respectfully recommended to the Secretary for his consideration and approval.
