**JUSTIFICATION:** Modification is requested because, the budget allocated for Dimasalang Bridge and Ubaan Bridge in the Final FY 2017 GAA were reduced to 6,000,000.00 and 6,000,000.00, compared to the 2017 NEP of 16,000,000.00 and 11,000,000.00, respectively. The approved appropriations will not be able to effectively widen both bridges, instead, the amount appropriated for both bridges will be combined and used to effectively widen one bridge. The District Engineering Office prioritized the Widening of Dimasalang Bridge; hence, the amount appropriated for Ubaan Bridge will be re-allocated to Dimasalang Bridge in order to address the widening of the said bridge. It is informed that the allotment for both project are within the same Program, Activity or Project (P/A/P). Further, the said projects are located within the same road section and the same implementing unit.

Enclosed are the required documents, such as, Evaluation Form (2017, version 2.1), Certificate of the Availability of Funds (CAF), Original and Modified Program of works (POW), Budget Profile (BP-202), BMS Data, Geo-tagged pictures and location Map for ready references.

In view of the above, the request for Modification of the Project is respectfully recommended for the Honorable Secretary's approval.
