Justification: Adjustment in station limits to harmonize sections that need upgrading with transition of at least sixty (60)					
 meters before and after each bridge for the four (4) bridges namely, Alimpatayan, Alipao, Candiis and Baloran Bridge. Decrease in physical target from 5.306 Lane Km to 4.04272 Lane Km due to the increase in quantity of the embankment to attain the average of 1.50 meters upgrading/raising of grade from the existing road to address severe flooding during heavy rains for safe and reliable road network along this flood prone area.
