- Modification of physical target resulting to change in station limit. Slightly decrease in physical target is due to additional work specifically excavation & removal of existing structure (16.51%), and Application of Reflectorized Thermoplastic Pavement Markings (2.28%). Hence, the unit cost is reasonable as it is within the range of the prevailing cost of the Department.
- And also need of modification due to change of scope of work from Asphalt Overlay to Concrete Reblocking since the existing adjacent road is concrete pavement. (Please see attached updated RBIA)

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
