JUSTIFICATION:

The budgets allocated for Hupas Bridge, Awa Bridge and Wawa Bridge in the Final FY 2017 GAA were reduced to Php 6,000,000.00, Php 5,000,000.00 and Php 20,000,000.00 compared to the 2017 NEP of Php 36,000,000.00, Php 40,000,000.00 and Php 150,000,000.00, respectively. The Individual appropriation will not be able to effectively widen the bridges; therefore, the amount appropriated for the three bridges will be combined and used to widen just one bridge. The District Engineering Office prioritized the Widening of Hupas Bridge, hence, the amount appropriated for Awa Bridge and Wawa Bridge will be re-allocated to Hupas Bridge, in order to address the widening of the said bridge. It is informed that the allotments for the said projects are within the same Program, Activity or Project (P/A/P). Further, the said projects are located within the same Road Section and implementing unit. Thus, the request for modification.

Enclosed are the required documents, such as, Evaluation Form (2017, version 2.1), Certificate of the Availability of Funds (CAF), Original and Modified Program of works (POW), Budget Profile (BP-202), BMS Data, Geo-tagged pictures and location Map for ready references.

In view of the above, the request for Modification of the Project is respectfully recommended for the Honorable Secretary's approval.
