JUSTIFICATION:

Physical target of the project was increased since the type of work is the replacement and widening of bridge into 4 lanes, thus increasing the physical target by 124.8 sq.m. (from 165 sq.m. to 289.8 sq.m.). The scope of work involves the concreting of road for both approaches with a total length of 0.444 lane km (222 lm). Further, the inclusion for the reserved payment of the acquisition of ROW since it was not provided in the FY 2017 GAA.

Attached are the required documents, such as Evaluation Form (2017 version 2.1). Program of Work (POW), Detailed Unit Price Analysis (DUPA), Straight Line Diagram, Location Map, Geotagged Photos, BP 202 and Certificate of Availability of Funds (CAF).

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
