Justification:					

Change in scope of work for CW1 from "Construction of Concrete Road" to "Construction of Road Slope Protection Structure" since the project is a new road opening design for a 4-lane road and will entail embankment with road slope protection to stabilize the road base and delineate the alignment. Drainage and slope protection structure comprises 23.37% of the construction cost. Concreting will be propose when the base is already stable for paving.

 Adjustment of ROW allocation based on the actual length of the road section (419.08LM) and as per actual assessed value of affected properties.

The derived unit cost and physical target is based on the approved plans, POW, DUPA, CPMD and Certificate of Reasonableness of Cost.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
