Justification:

• The physical target based on GAA is erroneous; the correct physical target should be 2.858 lane km with unit cost of ₱32,988,928.21/lane km.

 Provision of station limits to determine the exact location of the project as a result the physical target decreased from 10.53 lane km. to 2.858 lane km. due to the cost of earthworks and Inclusion of Miscellaneous Structures which are necessary to provide a safe and comfortable road to the riding public.

 This project is located in an Island where materials cost is extremely high due to double/triple handling cost. Aggregate subbase and surface courses are be taken from Cotabato City since the source at Municipality of Panglima Sugala, Sulu Province is Based on our evaluation, the submitted request for project modification is in order, hence approval hereof is recommended.
