- Provision of station limits to determine the exact location of the project us a recard the physical target decreased from 3.00 lane km. to 1.16 lane km. due to the cost of earthworks which constituted to 2.80% of the total project cost and it includes Miscellaneous Structures which are necessary to provide a safe and comfortable road to the riding public.
- This project is located in an Island where materials cost is extremely high due to double/triple handling cost. Aggregate subbase and surface courses are be taken from Cotabato City since the source at Municipality of Maimbung, Sulu Province is limited.
