Justification:

 Provision of station limits to determine the exact location of the project as a result the physical target decreased from 4.00 lane km. to 1.28 lane km. due to the cost of earthworks which constituted to 4.63% of the total project cost. Inclusion of Drainage and Slope Protection to prevent the road embankment from scouring/erosion and Miscellaneous Structures which are necessary to provide a safe and comfortable road to the riding public.

 This project is located in an Island where materials cost is extremely high due to double/triple handling cost. Aggregate subbase and surface courses are being taken from Cotabato City since the source at Municipality of Maimbung, Sulu Province is limited.
