- Modification is necessary due to change in station limits from K0010+700 K0010+850 to K0010+711.40
 K0010+795, resulting to a decrease in physical target from 2,240.00 to 1,718.45 square meter due to the following reason:
 - To an increase in average height of slope protection from 14.933 to 20.556 meter
 - To prioritize sections vulnerable to landslide/rock fall

To avoid gap and overlapping
