Justification:

- 1. Modification is necessary due to change in station limits from **K0016+380 K0016+450** to **K0015+415.00** K0015+456.80, resulting to a decrease in physical target from 1,672.00 to 1,286.03 square meter due to the following reason:
 - To an increase in average height of slope protection from 23.886 to 30.766 meter
 - To prioritize sections vulnerable to landslide/rock fall
 - To avoid gap and overlapping

2. Unit cost presented is within the allowable range set by this department.
