Justification:

- Modification is necessary due to change in station limits from K0098+150 K0098+350, K099+445 K0099+470 to K0098+160.00 K0098+330.00, resulting to a decrease in physical target from 4.274.00 to 3,404.15 square meter due to the following reason:
 - To an increase in average height of slope protection from 18.996 to 20.024 meter
 - To prioritize sections vulnerable to landslide/rock fall
 - To avoid gap and overlapping

2. Unit cost presented is within the allowable range set by this department.
