Modification is sought due to change in physical from 0.365 lane km to 0.302 lane km to reflect the correct chainage length of the station limits. The increase in unit cost per lane km is due to the removal of actual structures and obstructions, structure excavation, curb & gutter (precast) and provision of drainage structure at both sides of the road.
