Justification:

- 1) The modification is sought due to adjustment in the station limits to prioritize deteriorated road sections resulting to a change in physical target from 1.538 lane km to 1.004 and decrease in unit cost per lane km.
- 2) The excess allocation of CW1 was allocated to CW2 (Road Widening) and CW3 (Concrete Reblocking), which are both integral part of the project, and to maximize the project funding allocation.
- 3) ROW Component was already identified for payment of affected lots, structures, and properties.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
