Justification:

Modification is sought due to change in scope of work from "Asphalt Overlay" to "Concrete Reblocking" to prioritize deteriorated road sections. The decrease in physical target from 2.408 lane km to 1.78832 lane km is due to the provision of drainage and slope protection structures along the whole stretch of the road section resulting to an adjustment in the station limits. Attached is a Certification for Reasonableness of Cost dated March 1, 2021.
