Modification is sought due to adjustment in the station limits to include road sections in "poor" condition resulting to change in physical target from 1.236 lane km to 1.008 lane km wherein the road sections subject for asphalt overlay are only two lanes. The increase in unit cost per lane km is due to the removal of actual structures/obstruction, surplus common excavation, and the reblocking of shattered slabs. Attached is a Certification for Reasonableness of Cost dated February 24, 2021.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
