Justifications:

Modification is requested due to the following reasons:

- Adjustment in station limit from K1061 + 591 K1063 + 188 to K1061 + 591 K1062 + 625 to prioritize 1.
- the sections that needs slope protection in order to stabilize the slope and prevent erosion. Decrease in physical target from 2,446.50 sq.m. to 2,271.00 sq.m. due to actual condition of the project 2.
- that requires structural steel sheet piles (Type II) in a design of 6.0 meters long. Attached is a Certification from Regional Director as to reasonableness of the unit cost. 3.
