Justification:

- 1. Modification is sought due to adjustment in the station limits to prioritize road sections prone to rockfall.
- The decrease in physical target from 1,187.209 sq.m to 1,044.40 sq.m. is due to the design of the slope protection structure utilizing Permanent Ground Anchor, Rockfall Netting, and Hydroseeding.
