1. Modification is necessary due to change in station limits from K0417+752 - K0419+000 to K0417+900 - K0419+000 due to following reasons;

- The funds allocation is sufficient only to construct **1,098** I.m. road based on updated construction materials price data and labor rates.
- The decrease in physical target from 2.492 to 2.196 lane km due to the inclusion road safety component, however the unit cost presented is within the allowable range set by this department.
- Attached is the Certification of Reasonableness of Unit Cost dated February 26, 2021.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for Secretary's consideration and approval.
