Justifications:

- 1. The original proposal was Bogasong Br. 2 but Bogasong Br. 1 was inadvertently funded instead (attached is the excerpt from our FY 2021 Budget Proposal). The error was due to the fact that **BOGASONG** Br. 2 is named as **BAGASONG** Br. 2 in Bridge Management System (BMS), hence Bogasong Br. 1 was picked up instead. Attached is our request to rename the bridge from BAGASONG BR. 2 to BOGASONG BR. 2 in BMS.
- This bridge widening is complimentary to the widened road along Daang Maharlika that will improve traffic safety and increase the capacity of the road against traffic build up. It will also increase facilities for pedestrians and cyclists, to achieve optimum flow of traffic and thereby reduce pollution.
- 3. Change in physical target from 118.4 square meters to 114.48 square meters to correspond to the actual length of Bugasong Br. 2.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby, recommended for the Secretary's consideration and approval.
