1. Modification is necessary due to change in station limits from K0170+353 - K0170+433 to K0170+300

- K0170+580 for the following reasons:

• The funds allocation is sufficient only to construct 3,293.00 square meters of slope protection based on construction materials price data and labor rates.

The decrease in physical target from 7,776.00 to 3,293.00 square meters due to the required length of anchor bolts based on slope stability analysis, however the unit cost presented is within the allowable range set by this department.
