Justification:

1. Modification is necessary to reflect the physical target of **4.08** lane km since no physical target reflected in GAA 2021, wherein its design for slope protection and surface course with allocated fund for the project is only sufficient.
2. Unit cost also includes huge volume of earthworks and provision of chevron and pavement marking for road safety.
