1. Increased in physical target from 2.310 Lane Km to 3.460 Lane Km is due to the following reasons;					
• Unit cost was computed based from the approved plan, by using W= 4.0m; 0.20m thickness of pavement, installation of RCPC, Class IV and construction of slope protection at various sections.					
• By using updated materials price per validated CY 2020 4 th Quarter Construction Materials Price Data (CPMD) and Detailed Unit Price Analysis (DUPA) in the estimates.					
2. Unit cost presented is within the allowable range set by this department.
