Justification:

- 1. Decreased in physical target from 4.236 Lane Km to 4.023 Lane Km is due to the following reasons:
- Unit cost was computed based from the approved plan, by using 0.23m thickness of pavement, construction of slope protection and line canal at selected sections.
- By using updated materials price per validated CY 2020 4th Quarter Construction Materials Price Data (CPMD) and Detailed Unit Price Analysis (DUPA) in the estimates.
- 2. Attached is the certification of reasonableness of unit cost dated March 8, 2021.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
