To decrease the physical target from 2.2 Lane Km (based on AIP) to 1.7230 Lane Km which is the ٠ actual length of the project.

Increase in unit cost were due to inclusion of construction of slope protection structure (stone masonry), drainage system and asphalt overlay in the scope of works to improve road quality of public road users to accommodate increasing traffic volume going to Silvino Lubos, copy attached is Certificate of Reasonableness of Cost Estimate.
