Due to inclusion of paving of road shoulder and construction of drainage structure in the scope of works and to prioritize road sections that needs reconstruction of concrete pavement, station limits changed from K1083 + 747 - K1084 + 417 to K1081 + 938.5 - K1082 + 082, K1084 + 013 - K1084 + 623, thereby resulting to a decrease in physical target and an increase in unit cost, copy attached is Certificate of Reasonableness of Cost Estimate for your reference and guidance.
