The modification is sought due to:

- Change in station limits to prioritize flood-prone road sections and inclusion of CW2 which is necessary to complete the road features which resulted to the decrease in physical target of CW1 from 1,698 lineal meters to 958 lineal meters.
- 2. The increase in unit cost per lineal meter of CW1 is due to the provision of slope protection structure (grouted riprap and stone masonry) and curb and gutter (precast).
- 3. Attached is a Certification for Reasonableness of Cost dated March 2, 2022.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
