1. Station limits change to prioritize the location that needs immediate drainage structure to mitigate flooding in the area.

 Scope of works of the project involves the construction of Reinforced Concrete Box Culvert (2.4mx2.4mx15m) as type of drainage structure including slope protection works, in which a unit cost of P 130,666.67/ Lineal meters was arrived at, with a corresponding physical target of 15.00 Lineal meters, copy attached is Certificate of Reasonableness of Cost Estimate for your reference and guidance.
