Justification: Modification is sought	due to:	*			

1. Change in station limits to prioritize landslide prone sections which resulted to a decrease in physical target from 3,212.00 sq.m. to 1,493.96 sq.m. based from the actual area covered by the project.

 The increase in unit cost per sq.m. is due to the design of the project utilizing Active Non Mesh System with Erosion Control, voluminous quantities for earthworks, inclusion of drainage structure and provision of metal guardrails for road safety.

3. Attached is the Certification for the Reasonableness of Cost dated February 23, 2022.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said/request is hereby recommended for the Secretary's consideration and approval.
