- 1. Adjustment in station limits to prioritize landslide-prone road sections resulting to the decrease in physical target from 2,155.56 sq.m. to 1,772.328 sq.m.
- 2. The increase in unit cost per sq.m. is due to the design of the project utilizing Active Wire Mesh System (High Tensile), Permanent Ground Anchor, Grouted Riprap and Stone Masonry.
