Justification: Modification is sought due to: 1. Change in station limits to prioritize landslide prone road sections which resulted to a decrease in physical target from 2,777.78 sq.m. to 2,314.34 sq.m. based from the actual area covered by the project. 2. The increase in unit cost per sq.m. is due to the design of the project utilizing Active Wire Mesh System (High Tensile) and Permanent Ground Anchor. 3. Attached is the Certification on the Reasonableness of Cost dated February 18, 2022.
