Justification:

Decreased in unit cost, due to the following reasons:

- This bypass road will utilized the alignment of the existing barangay road, thus minimal embankment and excavation is required resulting to the decreased in unit cost.
- The existing concrete road is 150 mm. thk., which will be replaced by 280 mm. thk. Portland Cement Concrete Pavement (PCCP), 28 days, to conform to the DPWH Design Guidelines and Criteria.
- Based on conducted parcellary survey, there is a need for Right-of-Way Acquisition to compensate for affected property owners of structures/improvements, fruit bearing trees, and crops within the width and station limits of the project. The ROW acquisition unit cost is based on the prevailing market values in the locality.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
