- 1. Modification is sought due to change in the station limits resulting to a decrease in physical target from 2.012 lane km to 1.260 lane km. The increase in unit cost per lane km is due to inclusion of drainage and slope protection structures to prevent the newly widened road from erosion and flooding and the provision of concrete curb and gutter, metal guardrails, and warning/regulatory signs for road safety.
- 2. ROW Component was already identified for payment of affected lots, structures, and utilities.
- 3. Attached is the Certification on the Reasonableness of Cost dated February 7, 2022.
