The modification is sought due to:

- 1. Adjustment in the station limits to avoid overlapping of projects which resulted to the decrease in physical target from 3,354.00 sq.m to 2,836.61 sq.m.
- The increase in unit cost per sq.m. is due to voluminous quantities for earthworks and the inclusion of drainage and slope protection structures, concrete curb and gutter, and metal guardrails for road safety.
- 3. Attached is a Certification for Reasonableness of Cost dated February 18, 2022.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
