Justification:

The modification is sought due to:

- Adjustment in station limits to prioritize unwidened road sections resulting to the decrease in physical target from 2.640 lane km to 1.877 lane km. The increase in unit cost per lane km is due to the provision of solar LED street lights, internally illuminated (solar) pavement levelled marker/stud, and metal guardrails for road safety.
- 2. Attached is a Certification for Reasonableness of Cost dated February 04, 2022.
- 3. ROW Component was already identified for payment of affected lots, structures, and utilities.
