Justification:

Modification is sought due to:

- 1. Change in scope of work from "Construction of Concrete Road" to "Construction of Gravel Road" since the project is a new road opening traversing a mountainous terrain; thus; making the available fund of the construction of concrete road insufficient; therefore, the construction of gravel road was considered.
- 2. The decrease in physical target from 8.067 lane km to 1.50 lane km and increase in unit cost per lane km is due to the very extensive excavation works and slope protection structures. Attached is a Certification for Reasonableness of Cost dated February 04, 2022.
- 3. ROW Component was already identified for payment of affected lots/properties and structures.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
