Justifications:

- Modification is requested in view of change in station limits to prioritize road sections in immediate need of slope protection structure requiring volume to be excavated to suit actual field condition.

 Decrease in physical target in view of the inclusion of a 72.75% drainage & slope protection works and a 5.913% bridge construction % weight of the scope of work reflected in the submitted Certificate of Reasonableness of Cost Estimate duly signed & submitted by the District Engineer affecting the construction cost.
