1. Change in station limits to avoid overlapping of sections funded under the FY 2022 GAA and prioritize additional road sections requiring asphalt overlay which resulted to the increase in physical target from 5.430 lane km to 7.00 lane km and decrease in unit cost per lane km of CW1.

- The inclusion of CW2 is necessary to prioritize the reconstruction of deteriorated sections along the 2. national road.
