Justification: Modification is sought due to:

- 1. Adjustment in the station limits to prioritize road sections requiring asphalt overlay resulting to a decrease in physical target from 20.909 lane km to 15.24 lane km. The increase in unit cost per lane km is due to the reconstruction of shattered slabs and provision of Reflectorized Thermoplastic Pavement Markings.
- 2. Attached is the Certification on the Reasonableness of Cost dated February 7, 2022.
