Justification:

Modification is sought due to:

1. Change in the station limits to prioritize road sections requiring asphalt overlay resulting to a decrease in physical target from 52.406 lane km to 16.048 lane km. The increase in unit cost per lane km is due to the reconstruction of shattered slabs and provision of Reflectorized Thermoplastic Pavement Markings. The adjusted unit cost is within the prevailing cost of the Department. Attached is the Certification on the Reasonableness of Cost dated February 7, 2022.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
