<b>Justification:</b> <ul style="list-style-type: none"><li>• The deleted station limit is due to the overlapping with the widening project of Regional Office.</li><li>• The 9.03% decrease in physical target is due the 9.93% increase in unit cost which resulted from the change in the design requirements that includes the construction of 0.9m x 1.2m. lined canal.</li><li>• The addition of lined canal, guardrails and curb and gutter and other road facilities to the scope of work also added to the change in physical target.</li></ul>
