## Justification:

Modification is sought due to change in station limits to prioritize the inclusion of additional 4,201.44 sq.m. of slope protection structure along landslide prone road sections which resulted to an increase in physical target from 5,555.56 sq.m to 9,757 sq.m and decrease in unit cost per sq.m.
