The modification is sought due to:

- 1. Change in station limits to prioritize landslide prone road sections resulting to the decrease in physical target from 5,166.67 sq.m to 4,266.52 sq.m based on the actual area covered by project.
- 2. The increase in unit cost per sq.m is due to the design of the project utilizing Active Wire Mesh System (Erosion Control Mats, High Tensile Wire & Permanent Ground Anchor).
- 3. Attached is a Certification for Reasonableness of Cost dated March 1, 2022.
