Justification:

The increase in physical target is due the decrease in unit cost which resulted from the change in the design
requirements that includes the construction of 1m x 1m lined canal and the sufficiency of fund to cover the
construction of drainage system.

 The addition of reconstruction of concrete pavement to the scope of work also added to the change in physical target.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
