### Justification:

- Modification is sought due to the decrease in physical target by 18.18% due to the design of a roadway width of 6.70 meters (2 lanes at 3.35 meter per lane) which involves 0.28 meter thick PCC Pavement and brought by adequate provision of Retaining Wall and Lined Canal which accounts to 45.49 % of the total project cost. Provision of metal guardrail is also incorporated in the project to ensure safety of the end users.
- Derived unit cost is based on approved POW and DUPA.

Based on our evaluation, the submitted request for modification of the said project is in order. Hence, the said request is hereby recommended for Secretary's consideration and approval.
