• Increase in physical target since the design width of the bridge increased by 0.28 sq.m. (from 9.54m to 9.82m) resulting to additional funding requirement.

Unit cost increase since the bridge width per lane is more than 4 meters which requires 3 girders based on the Design Guidelines, Criteria and Standards, Bridge Design Vol. 5.
 The area of the BOW Acquiritien was descreased beside vol.

The area of the ROW Acquisition was decreased based on the actual survey/validation.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
