

Justification:					
Modification is sought due to the following reasons;					
1. The <u>decrease in project target length</u> is due to the design requirement of the roadway which involves 0.30 meter thick PCCP and change in station limits due to the on-going MVUC funded projects within the area; and 2. Some station limits were cut and transferred to another station limits where the condition of the road surface are bad.
