Justification:					
Change in station limits and decrease in physical target from 10.600 Lane km to 9.800 Lane km were due to the following:					
<ul style="list-style-type: none"> K1424+996.10 and K1425+002 are equivalent limits. K1424+996.10 is non-existent as per RBIA since the chainage from K1424 up to K1425 is only 994 meters, thus, it was changed to K1425+002; End limit revised from K1434+482.90 to K1429+923 since only 4.900 km/ 9.800 Lane km can be covered with the allocated amount of Php 50.00 Million. <u>Scope of works includes installation of metal beam guardrails, application of reflectorized thermoplastic pavement markings, and installation of raised pavement markers, hence, higher unit cost.</u> 					

Based on our evaluation, the herein request is found in order, hence approval is hereby recommended.
